Initial Producer Evaluation

Before you join or register with the PRO, you may need help evaluating whether you are considered a producer under each state's program, particularly in cases where the same producers could be responsible for the same covered materials. We can help you evaluate your producer status under the laws as written - and how California's proposed rules may shift that responsibility.

Initial Covered Material Analysis

In some cases it is not always obvious whether a material is regulated under a particular state program. For example, what is considered "single use" or "packaging" may not always be self-evident. Moreover, it may not be clear whether a material falls within an exemption or exclusion. We can help you with that analysis - and where applicable, identify key differences between the statute itself and regulations or proposed applications.

Ongoing Program Requirements

As these programs develop, you may have additional needs for support. For example, we can help you document your compliance program and establish SOPs for your company. We can also support your obligation to report data and, in California, to prepare a source reduction plan.
